PLEASE TAKE NOTICE, the Board of Managers of the Middle Snake Tamarac Rivers Watershed District, sitting as the drainage authority for redetermination of benefits to State Ditch #3 (SD #3) will hold a final hearing on the viewers' report of redetermined benefits and damages for SD #3. The hearing shall be held at 5:30p.m. on Monday, June 24, 2024, at the Community Center in Argyle MN.
